**RESOLUTION APPOINTING KATTY C. WONG-TAYLOR AS MUNICIPAL PROSECUTOR FOR THE TOWNSHIP OF RARITAN**

**WHEREAS**, there is currently a vacancy in the position of Municipal prosecutor of the Township of Raritan; and

**WHEREAS**, local Public Contracts Law ( N.J.S.A. 40A:11-1,et seq.) requires that the resolution authorizing the award of contracts for Professional services without competitive Bids must be publicly advertised; and

**WHEREAS**, N.J.S.A. 2B:24-4(a) and Chapter 2.24 of the revised General Ordinances of the Township of Raritan allow the Township Committee to appoint a Municipal Prosecutor; and

**WHEREAS**, Katty C. Wong - Taylor ESQ. is qualified under the Statute to serve as Municipal Prosecutor; and

**WHEREAS**, the Township Committee desires to appoint Katty C. Wong - Taylor ESQ. as Municipal Prosecutor.

**NOW THEREFORE BE IT RESOLVED**, by the Mayor and Township Committee of the Township of Raritan, County of Hunterdon, State of New Jersey, as follows:

1. Katty C. Wong - Taylor ESQ. is hereby appointed as acting Municipal Prosecutor for the term commencing December 6, 2016 and ending January 5, 2017 at a per diem rate of \$350.00 per Court session.
2. This resolution shall take effect immediately.

**BE IT FURTHER RESOLVED**, that this appointment is awarded as Professional Services under the provisions of the Local Public Contracts Law as said appointment encompasses Professional Services recognized, licensed, and regulated by law; and

**BE IT FURTHER RESOLVED**, that a copy of this resolution shall be published in the Hunterdon County Democrat within 10 days of adoption.
